










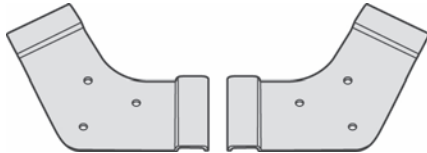

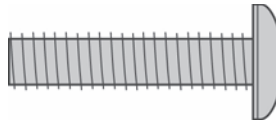


□ Outer Mounting Plate, Part Number 443.80, Qty - 2



□ Left Inner Mounting Plate, Part Number 443.79, Qty - 1

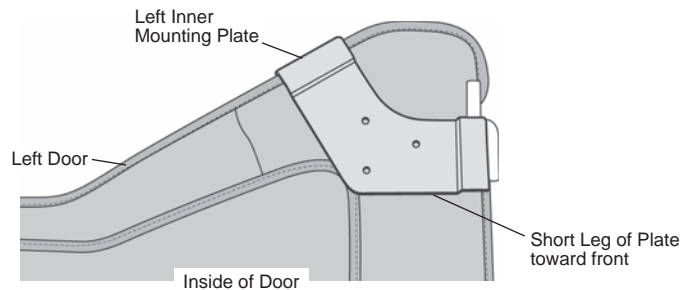
□ Right Inner Mounting Plate, Part Number 443.78, Qty - 1



□ 1/4-20 x 1-1/4 Phillips Pan Head Screw, Part Number 397.22, Qty - 6

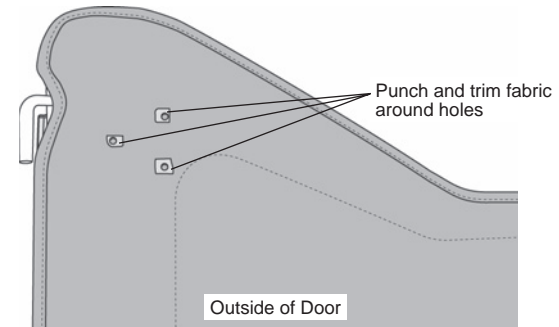
1 Install Inner Mounting Plate

Hook the plate over the top front corner of the door with the short leg of the bracket toward the front of the door.



2 Punch Holes

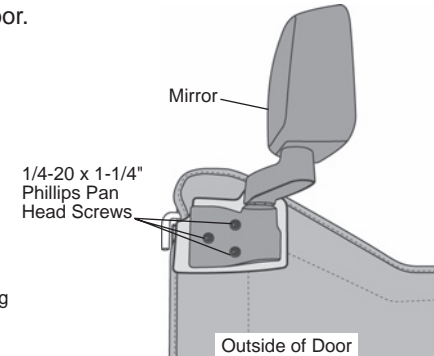
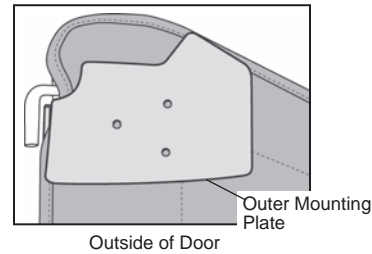
Push the bracket up as high as it will go. Locate the tapped holes in the bracket with an awl and poke a hole in the fabric at each hole location. Cut away the fabric around each hole.



3 Install Outer Mounting Plate and Mirror

Lay an Outer Mounting Plate on the outside of the door and align the holes with the holes in the Inner Mounting Plate. Hold the left mirror over the outer plate and mount it to the inner plate with three (3) 1/4-20 x 1-1/4" Phillips Pan Head Screws. Alternate tightening each screw until the mirror is secure.

Repeat Steps 1 - 3 on the right door.
